#### Approval of Authorization to Transfer Between Warrant Articles 2.

The Superintendent asked for the Board's annual approval to allow for the transfer of money between articles if necessary.

ON A MOTION BY Amy Rouse, seconded by Jennifer Poirier, the Board voted that pursuant to section 1485(4) of Title 20-A, the Superintendent of Schools be authorized to transfer not more than 5% of the total appropriation for any cost center in the current fiscal year operating budget [and not more than \$1,838,396 in the aggregate] to another cost center or among other cost centers, provided that the total current fiscal year operating budget shall not be increased by such transfers.

3. <u>Vote to Authorize Issuance of a \$1,750,000 Tax Revenue Anticipation Note</u>

ON A MOTION BY Goff French, seconded by Peggy Lovejoy, the Board voted that the vote entitled, "Vote to Authorize Issuance of a \$1,750,000 Tax and Revenue Anticipation Note," be approved in form presented to this meeting and that the Secretary file an attested copy of said vote with the minutes of this meeting.

### 5. Presentation on 2020-2021 District Budget

The Superintendent presented an overview of the proposed 2020-2021 District Budget. The overall budget is down (-\$101,678) or (-.28%). The local appropriation is down (-\$182,073) or (-1.28%). A summary of the budget highlighted reductions over the current year due to retirements and resignations, contractual obligations and new special education needs.

Upon approval of the proposed budget, it was the consensus of the Board to hold a special in-person meeting at the Skowhegan Area High School gymnasium on Tuesday, June 9<sup>th</sup> at 7:00 pm to approve and sign warrants and provide for public in-person comment regarding the approval of the 2020-2021 Budget Warrants.
